The Bourse and CDCC wish to inform all equity option participants that the name of the ProEx Energy Ltd. company ("ProEx") has been changed to "Progress Energy Resources Corp.". At the market opening on Wednesday, January 21, 2009, trading will continue in the company's common shares under the new name, new stock symbol and new CUSIP number.

#### **CDCC - adjustment details:**
