FINAL CONTRACT ADJUSTMENT Silver Wheaton Corp. (SLW) CUSIP, SYMBOL AND NAME CHANGE

The Bourse and CDCC wish to inform you that “Silver Wheaton Corp.” has changed its name to “Wheaton Precious Metals Corp.” and that the trading symbol on the Toronto Stock Exchange for Silver Wheaton Corp. will change from “**SLW**” to “**WPM**”. The Company will commence trading under the symbol “**WPM**” on the Toronto Stock Exchange at the opening of trading on May 16, 2017.

CDCC - Adjustment Details:

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Silver Wheaton Corp. options will be adjusted as follows:

- **EFFECTIVE DATE:** **May 16, 2017**
- **NEW OPTIONS SYMBOL:** **WPM**
- **NUMBER OF CONTRACTS:** **Unchanged**
- **MULTIPLIER:** **Unchanged**
- **DELIVERABLE PER CONTRACT:** **100 common shares of WPM**
- **POSITION AND EXERCISE LIMITS:** **Position and exercise limits will remain unchanged at 250,000 contracts**

Bourse de Montréal Inc. - Adjustment Details:

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the change and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.

The existing series of SLW options class will be transferred to the WPM options class representing the new deliverable.
