The Bourse and CDCC wish to inform you that on July 16, 2008, Barclays Global Investors Canada Limited (Barclays Canada) announced a unit split, on a four-for-one basis, for the iShares CDN S&P/TSX Global Gold Index Fund (XGD). Unitholders of record of the XGD fund on August 8, 2008 will automatically participate in the unit split. The XGD fund will begin trading at the split-adjusted price on August 6, 2008 on the Toronto Stock Exchange. The split will become effective on August 8, 2008, following which additional units will be distributed to unitholders' accounts.
