The Bourse and CDCC wishes to inform you that the trading symbol on the Toronto Stock exchange for Colliers International Group Inc. will change from “CIG” to “CIGI”. The company will start trading under the new symbol on the Toronto Stock exchange at the opening of business on November 1, 2016.
