FINAL CONTRACT ADJUSTMENT Horizons BetaPro NYMEX Crude Oil Bull Plus ETF (HOU) Reverse Unit Split

THE FOLLOWING INFORMATION IS PREPARED FOR THE CONVENIENCE OF <u>CANADIAN DERIVATIVES CLEARING CORPORATION (CDCC) MEMBERS AND BOURSE</u> <u>DE MONTRÉAL INC. (THE BOURSE) APPROVED PARTICIPANTS.</u> THIS DOCUMENT IS AN UNOFFICIAL SUMMARY OF CERTAIN TERMS OF THE AFOREMENTIONED ADJUSTMENT. CDCC AND THE BOURSE ACCEPT NO RESPONSIBILITY FOR THE ACCURACY OR COMPLETENESS OF THE SUMMARY. CDCC MEMBERS AND BOURSE APPROVED PARTICIPANTS MUST ENSURE THEY HAVE REVIEWED THE DOCUMENTATION PUBLISHED BY THE ISSUERS INVOLVED IN THIS CORPORATE ACTION.

The Bourse and CDCC wish to inform you that Horizons ETFs Management (Canada) Inc. ("Horizons ETFs") will consolidate the units of Horizons BetaPro NYMEX Crude Oil Bull Plus ETF ("HOU"). The reverse unit split on the basis of a 1 for 2 ratio will be effective at the opening of markets on November 26, 2015.

CDCC - adjustment details:

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all HOU options will be adjusted as follows:

- <u>EFFECTIVE DATE:</u> November 26, 2015
- > <u>OPTIONS SYMBOL:</u> HOU will become HOU4
- <u>NUMBER OF CONTRACTS:</u> Unchanged

CDCC will not adjust any outstanding escrow receipts.

The Bourse - adjustment details:

It is important to note that on the effective date mentioned above, all open orders on this option class <u>will</u> <u>not be automatically modified</u> to reflect the reverse split and will therefore have to <u>be re-entered</u> into the Montreal Automated System (SAM) by the approved participants.

The existing series of HOU option class will be transferred to the HOU4 option class representing the new deliverable. Actual series that do not have open interest will not be adjusted.

Numerical Example

For a member holding a long put strike \$4.00 position and considering that HOU Fund's closing price on November 23 2015 is \$2, 65, the intrinsic value of the option prior to the adjustment is:

Intrinsic Value = $4.00 \times 100 - 2.65 \times 100$ = 135.00



After the adjustment, the intrinsic value of the option will be:

Intrinsic Value = New Strike Price x New Multiplier – New Underlying Price x New Deliverable = \$8.00 x 50 - \$5.30 x 50 = \$135.00
