The Bourse and CDCC wish to inform you that the trading symbol on the Toronto Stock Exchange for Teck Resources Limited Class B subordinate voting shares will change from “TCK.B” to “TECK.B”. The company will start trading under the new symbol on the Toronto Stock Exchange at the opening of business on December 5, 2016.

#### **CDCC - Adjustment Details:**

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all TCK options will be adjusted as follows:

- **EFFECTIVE DATE:** December 5, 2016
- **OPTIONS SYMBOL:** TCK changes to TECK
- **NUMBER OF CONTRACTS:** Unchanged
- **MULTIPLIER:** Unchanged
- **DELIVERABLE PER CONTRACT:** 100 Class B shares of Teck Resources Limited (TECK.B)
- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will remain unchanged at 250,000 contracts.
- **CUSIP :** There will be no change to the CUSIP number



**Bourse de Montréal Inc. - Adjustment Details:**

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the change and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.

The existing series of TCK options class will be transferred to the TECK options class representing the new deliverable.
