FINAL CONTRACT ADJUSTMENT Genworth MI Canada Inc. (MIC) Special Cash Dividend

THE FOLLOWING INFORMATION IS PREPARED FOR THE CONVENIENCE OF CANADIAN DERIVATIVES CLEARING CORPORATION (CDCC) MEMBERS AND BOURSE DE MONTRÉAL INC. (THE BOURSE) APPROVED PARTICIPANTS. THIS DOCUMENT IS AN UNOFFICIAL SUMMARY OF CERTAIN TERMS OF THE AFOREMENTIONED ADJUSTMENT. CDCC AND THE BOURSE ACCEPT NO RESPONSIBILITY FOR THE ACCURACY OR COMPLETENESS OF THE SUMMARY. CDCC MEMBERS AND BOURSE APPROVED PARTICIPANTS MUST ENSURE THEY HAVE REVIEWED THE DOCUMENTATION PUBLISHED BY THE ISSUERS INVOLVED IN THIS CORPORATE ACTION.

The Bourse and CDCC wish to inform you that the Board of Directors of Genworth MI Canada Inc. ("**Genworth**" or the "**Company**"), approved on February 19, 2020 a special cash dividend of CAD \$2.32 per common share. The special dividend will be paid on March 19, 2020 to shareholders of record as of the close of business on March 4, 2020. The ex-dividend date is March 3, 2020.

The Bourse and CDCC will take into account the special dividend by adjusting the strike prices of Genworth MI Canada Inc.'s (MIC) options, by an amount equivalent to the special dividend that is CAD \$2.32.

Special Dividend - Adjustment Details:

- **EX-DATE:** **March 3, 2020**
- **RECORD DATE:** **March 4 , 2020**
- **PAYABLE DATE:** **March 19, 2020**

CDCC - Adjustment Details:

According to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Genworth MI Canada Inc. (MIC) options will be adjusted as follows:

- **EFFECTIVE DATE:** **March 3, 2020**
- **OPTIONS SYMBOL:** **Unchanged**
- **NUMBER OF CONTRACTS:** **Unchanged**



- **MULTIPLIER:** Unchanged
- **DELIVERABLE PER CONTRACT:** 100 common shares of MIC
- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will remain 50 000 contracts.
- **CUSIP:** Unchanged
- **STRIKE PRICES:** An adjustment of CAD \$2.32 will be made for all existing series.

Bourse de Montréal Inc. - Adjustment Details:

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the change and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.
