The Bourse and CDCC wish to inform you that "Cott Corp." has changed its name to "Primo Water Corporation".

The company will start trading under the new name, new symbol ("PRMW") and CUSIP on the Toronto Stock Exchange at the opening of business on March 3, 2020.
