The Bourse and CDCC wish to inform you that Research In Motion (“RIM”) announced on January 30, 2013 that the company will operate under the name “BlackBerry”. The company’s common shares will start trading under a new symbol (“BB”) on the Toronto Stock Exchange at the opening of business on February 4, 2013.
