FINAL PLAN OF ARRANGEMENT Seabridge Gold Inc. (SEA) Spin-Off

The Montreal Exchange and CDCC wish to inform you that Seabridge Gold Inc. ("Seabridge" or the "Company") (TSX: SEA, NYSE:SEA) has completed its previously announced spin-out transaction of Valor Gold ("Valor") by way of plan of arrangement under the Canada Business Corporation Act which took effect on June 3, 2026.

Under the spin-off, shareholders of Seabridge ('Old Seabridge Shares') will receive 1 common share of new Seabridge share (a 'New Seabridge Share') and one common share of Valor (a 'Valor Share') for every approximately 1.957 Seabridge shares held. A follow up circular will be issued to address fractional share allocation which will determine the rounding up/down process.

It is anticipated that the Old Seabridge Shares will be suspended from trading on the Toronto Stock Exchange as at the closing of trading on June 4, 2026. The New Seabridge Shares will be listed for trading under the new CUSIP 811927102 on TSX as at the opening of trading on June 5, 2026. The New Seabridge Shares will continue to be 'SEA' on TSX

It is similarly expected that Valor Shares will be listed for trading on TSX under the symbol 'VGC' as at the opening of trading on June 5, 2026 under the CUSIP 919921106.

CDCC - Adjustment Details - Options:

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Seabridge Gold Inc. options will be adjusted as follows:

- **EFFECTIVE DATE:** June 5, 2026
- **OPTIONS SYMBOL:** SEA will become SEA1
- **NUMBER OF CONTRACTS:** Unchanged
- **MULTIPLIER:** 100

- **NEW DELIVERABLE PER SEA1 CONTRACT:**
 - 100 common shares of New Seabridge Shares (SEA)
 - 51 shares of Valor (VGC) (100x0.510986)
 - An approximate cash consideration equivalent to 0.0986 (100x0.000986). A follow up circular will be issued to confirm the amount

- **STRIKE PRICES:** Unchanged

- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will remain unchanged at 200 000 contracts.
