The Bourse and CDCC wish to inform you that the Board of Directors of Genworth MI Canada Inc. ("Genworth" or the "Company"), approved on September 12, 2019 a special cash dividend of CAD \$1.45 per common share. The special dividend will be paid on October 11, 2019 to shareholders of record as of the close of business on September 26, 2019. The ex-dividend date is September 25, 2019.

The Bourse and CDCC will take into account the special dividend by adjusting the strike prices of Genworth MI Canada Inc.'s (MIC) options, by an amount equivalent to the special dividend that is CAD \$1.45.
