The Bourse and CDCC wish to inform all equity option participants that the name of the company MDS Inc. ("MDS") has been changed to "Nordion Inc.". At the market opening on Monday, November 1, 2010, trading will continue in the company's common shares under the new name, Cusip and under the new stock symbol NDN.
