FINAL CONTRACT ADJUSTMENT Tourmaline Oil Corp. (TOU & FOU) Special Cash Dividend

The Bourse and CDCC wish to inform you that the Directors of Tourmaline Oil Corp. (the "**Corporation**"), declared on November 5, 2025, a special cash dividend of CAD \$0.25 per common share. The special dividend will be paid on November 25, 2025 to shareholders of record as of the close of business on November 14, 2025. The ex-dividend date is November 14, 2025.

The Bourse and CDCC will take into account the special dividend by adjusting the strike prices of Tourmaline Oil Corp. (TOU) options, by an amount equivalent to the special dividend that is CAD \$0.25.
