Bourse de Montréal Inc. and CDCC hereby inform you that the existing series of CL (Canada Life Financial Corporation) will be transferred to the new CLY class representing the new deliverable of the CL options.

It is important to note that on the effective date, July 10, 2003, all open orders on the CL options class not transferred to the CLY class will have to be re-entered again in the Montreal Automated System (SAM) by the approved participants.

Moreover, be informed that no new series or new expiry months will be listed on the new symbol CLY. In addition, **it is the responsibility of all approved participants to ensure that only CLOSING transactions are permitted on the new CLY option class.**
